## **Privacy Policy**

Sharon's School of Dance is serious when it comes to protecting your privacy.

1. We collect, names, phone numbers, addresses, email address and relevant information to enroll students.
2. We collect medical information. This is to give staff members information in the best way to educate students. It is also used for medical emergencies (doctors, EMT's etc.) In the event that we must share this information for a medical emergency, parents or emergency contacts are notified immediately.
3. Credit card information is not retained by Sharon's School of Dance, or by our software program (Studio Pro). Credit cards are processed through Stripe, Paypal, CashApp, and Venmo. Credit card information will no longer be requested to enroll in Auto Pay through paperwork. Parents must now enroll directly from their parent portal.
4. Sharon's School of Dance will never sell your information. Information is only used when there is a proper reason to do so.
5. Be mindful that information shared to our Facebook page, Instagram page or website, is subject to their individual policies.

## **Studio Policies**

1. Dress code must be followed.
2. All shoes & equipment must have student's name on them.
3. Students are required to contact the school if they will be absent and arrange for a make-up day.
4. No profanity or adult subject matter inappropriate for children. *(This includes talks of politics)*
5. No hitting, kicking or spitting. No violence of any kind, actual or implied.
6. Students may not have gum, food or drinks in the studio.
7. No smoking inside the building
8. No littering on studio grounds (including cigarette butts)
9. Please clean up your food/drinks in waiting room.

11. No gossip! Cell phones must be turned off or silenced.
12. All students & parents must be respectful of the teachers, staff, and other dance families.
13. No street shoes in the dance room.
14. Tuition is due the 1<sup>st</sup> of each month. A \$5.00 late fee will be added to account on the 6<sup>th</sup>, if not paid.
15. Students may not use outside choreographers for competition numbers without permission from the director.



### Note

*Students are not permitted to attend other studios while enrolled at Sharon's. However, exceptions can be made for schools that provide classes we do not, such as ballroom dancing or gymnastics. Additionally, exceptions may be granted for adult students under specific circumstances. If you have any doubts, please feel free to inquire.*
